स्वच्छ भारत अभियानांतर्गत भिवंडी शहर स्वच्छ व सुंदर राहण्यासाठी पालिका आयुक्त डॉ. योगेश म्हसे निकराचे प्रयत्न करित आहेत. मात्र स्वच्छता विभागातील अधिकारी स्वच्छतेच्या कामात दुर्लक्ष करित असल्याने शहरात स्वच्छतेचा बोजवारा उडाला आहे. चक्क पालिका मुख्य कार्यालयाच्या संरक्षक भिंतीवरच पादचारी लघुशंका करित असल्याने

पालिका प्रशासनाचा स्वच्छतेचा दावा फोल ठरला आहे. महापालिका प्रशासनाने स्वच्छतेच्या जनजागृतीसाठी शाळकरी मुलांकडून भिंतीवर चित्रे रंगवून घेतली आहेत. मात्र या चित्रांवरच पादचारी

लघुशंका करित असल्याचे दिसून येत आहे. सार्वजनिक ठिकाणच्या अस्वच्छतेला पायबंद बसावा यासाठी पालिकेने दंडात्मक कारवाईसाठी पाच प्रभागांमध्ये विशेष अधिकारी, कर्मचाऱ्यांची नियुक्ती केली आहे. मात्र तेही उघड्यावरच्या लघुशंकेला पायबंद घालण्यास अपयशी ठरले आहेत. पालिकेच्या आरोग्य विभागातील अधिकारी फक्त कागदावर स्वच्छतेची मोहीम यशस्वी झाल्याचा दावा करित आहेत. मात्र जमिनीस्तरावर स्वच्छतेचे धिंडवडे उडाल्याने प्रशासनाच्या विरोधात शहरवासीयांमध्ये तीव्र संताप व्यक्त केला जात आहे. महानगरपालिकेने शासनाच्या स्वच्छ सर्वेक्षण २०१८ साठी पुढाकार घेतला आहे. त्या अंतर्गत शहरातील नागरिकांना

स्वच्छतेसाठी आवाहनही केले जात आहे.

पालिका प्रशासनाच्या आवाहानानुसार नागरिक तक्रारीही करित आहेत. मात्र स्वच्छता अधिकारी नागरिकांच्या तक्रारीकडे दुर्लक्ष करित आहेत असा आरोप विरोधी पक्षनेते श्याम अग्रवाल यांनी केला आहे. जर भिवंडी शहरात लोकसंख्येनुसार, सार्वजनिक शौचालय नाही आहेत. काही विभागात खूप लांब शौचालय आहे. थंडीच्या दिवसात लघुशंकेवर नियंत्रण रहात नाही आणि मनात नसतानाही आडोश्याचा वापर करावा लागतो. यामुळे पहिला पालिकेने सार्वजनिक शौचालय वाढवावे मग भिवंडी शहर स्वच्छ अभियान राबवावे असे काही नागरिकांनी सांगितले.
