While they continue to be present in these marketplaces, they are also looking at increasing revenues from their own channels and building a profitable digital business. Shoptimize, a start-up based in Pune, has managed to convince brands to consider this option and realise the potential of playing directly in the online market space. Shoptimize demonstrated success early with the Haldiram brand of Nagpur.

They started with the last Diwali and were inundated with on-liners orders; Haldiram had to shut down their online store for some time. They now believe in selling on their own rather than in external marketplaces.

Luminous India has worked with them on the platform for a year and half and their brand store has become one of the key elements in their e-commerce journey. They have had a good experience going online on their own. Schneider Electric, Lotus Herbal, Gits, Mother's Recipe, Liberty Shoes, Camlin Kokuyo and Zippo, among others, have joined the list.

Shoptimize has signed up with around 100 brands in the electronics, food, home appliances, consumer electronics, lifestyle and fashion segments, and is hoping to reach 1,000 brands in three years with 800 of these brands in India. Plans for expansion in the US and Asia are in the works.

Shoptimize, founded by CEO Mangesh Panditrao and CTO Vivek Phalak, provides brands an
